Ask assistant welfare officer to complete British Canoeing Awarding Body safeguarding training if needed.

### **- Juniors**

Continue to provide weekly pool or docks sessions to develop enjoyment and skills.

Continue to offer junior trips to widen juniors paddling experiences. A trip at least every 2 months.

Provide older/ more experienced juniors with options to develop in particular sections, maybe as a small junior group joining in with sessions eg river kayaking, play boating, canoe polo, slalom.
